The public hearing was scheduled to hear public comment regarding proposed Ordinance No. 488, which, if adopted, would update Chapters 2, 11, 12, and 13 of the Village Code of Ordinances. The updates would create an Ordinance pertaining to possession of e-cigarettes by minors; create Ordinance pertaining to possession of controlled substances; create Ordinance pertaining to sexting by minors; create Ordinance restricting use of facsimile firearms; revise Ordinance addressing harassing or obscene telephone calls, text messages, social media applications, and e-mails; create Ordinance pertaining to lewd and lascivious behavior and making lewd, obscene or indecent drawings; revise Ordinance addressing animals running at large and barking dogs; create Ordinances pertaining to vacating alcohol beverage licensed premises, underage persons, and wearing apparel by persons involved in the operation of any licensed premises; create Ordinance setting forth a point value for alcohol beverage license violations and revocations and suspensions; and update the weeds and grass ordinances.

There were no citizens present to speak for or against the proposed Ordinance.

# **Street Committee**

Trustee Brown reported on the June 5, 2019, Street Committee meeting. Loren Schwier and Teresa Schnitzler informed the Committee that this year's sidewalk inspections have been completed. There are sixty sidewalks in need of repair or replacement. Loren Schwier obtained estimates for grinding, and the average is \$75 per grind. Sidewalk block replacement is in the range of \$150 to \$175 each. The process needs to be simplified. Presently, owners are notified, a time frame is given for the owner to respond, inspections are performed to finalize a Village-contractor repair list, and then inspections are required again on owner-repaired sidewalks. In some cases, owners are stating they will take care of the repairs, and those repairs are not being made or are being done incorrectly. The Committee was asked to consider eliminating the option for the property owner to make the repairs. Loren Schwier stated the Village is able to have the repairs and replacements completed at a much lower cost because of the advantage of multiple locations. The Committee noted that because the sidewalks have been inspected and marked already, most property owners anticipate a notice to repair is coming and some may have already contracted for repairs. It was felt a change to remove the property owner option to repair or replace should be considered beginning next year. An ordinance revision would be presented to the Village Board, public hearings scheduled so the public has ample opportunity to comment on the change, and then consider adopting a revised ordinance later this year. Schnitzler will draft a proposed letter to be sent to property owners this year for comment by the Street Committee. Loren Schwier informed the Committee tree and brush disposal has become an issue for many municipalities. The estimated cost to hire tree limb and brush chipping at the Buol Road compost site will be \$15,000. The cost to rent a small grinder is \$10,000 a week. This is cost-prohibitive for the Village. The Committee directed Loren Schwier to talk with an excavator about moving the materials preventing full use of the Buol Road and to consider alternate methods for tree limb and brush disposal.

Motion by Trustee Brown, seconded by Trustee Leicht to approve the minutes of the Street Committee meeting held on June 5, 2019, as presented. Roll call vote: Unanimous aye. Motion approved.

Motion by Trustee Leicht, seconded by Trustee Brown to adjourn the meeting at 7:23 p.m. Approved by voice vote.
