Motion by Trustee Lautz, seconded by Trustee Deal to approve the issuance of a Temporary Class B Retailer's License to the West Salem American Legion Post 51 for Family Fun Day scheduled for Sunday, September 4, 2016, at the West Salem Community Shelter. Roll call vote: Unanimous aye.

Ordinance No. 475

Attorney Klos presented proposed Ordinance No. 475 which amends Section 7.06 of the Code of Ordinances regarding razing buildings. Section 7.06 presently authorizes the Village to assess as a special charge the costs of razing structures as ordered by the Building Inspector. The proposed amendment to Section 7.06 adds the provision to authorize not only the costs of razing structures, but also the costs to secure the structure.

Motion by Trustee Schumacher, seconded by Trustee Hennessey to waive a second reading of proposed Ordinance No. 475 regarding razing buildings. Roll call vote: Unanimous aye.

Trustee Brown offered amendments to the Ordinance stating his proposals would add clarification and organization. Trustee Brown suggested subparagraph lettering and language to clarify the Village has not only the powers set forth in Section 66.0413 of the Wisconsin Statutes, but also the authorities set forth in a new subsection.

Motion by Trustee Brown, seconded by Trustee Deal to approve Ordinance No. 475 with the amendments. Roll call vote: Unanimous aye.

Alcohol Beverage License

Motion by Trustee Schumacher, seconded by Trustee Hennessey to approve the issuance of an alcohol beverage license to Lindsey K. Korth. Roll call vote: Unanimous aye.

Shared Ride Update
