### Frequently Asked Questions:

## 1. My court date is a month away. Does my fine double or my vehicle registration get suspended while I contest a ticket?

Answer: No. Your fine freezes at whatever stage your ticket was in at the date you filed a Parking Ticket Contest Form. If you are found guilty, your fine remains that amount it was frozen at.

## 2. Can my vehicle registration still be suspended if I fail to pay the required fine amount?

Answer: Yes. If a fine is not paid, your vehicle registration can be suspended. In addition, if you contest a ticket in court and are found guilty and fail to pay, your driver's license can also be suspended.

# 3. Am I required to personally appear at court to contest a ticket, or can I speak with the village attorney in advance of the court date?

Answer: No. You must personally appear at your assigned court date and time. Court is typically held on the third Monday of each month at 5:30pm.

# 4. Can I still contest a ticket if I lost it? Answer: Yes, as long as you can provide the license plate of the vehicle or the name it is registered to and we successfully locate the



#### INSTRUCTIONS ON HOW TO CONTEST A PARKING TICKET:

- 1. Make contact with the Chief of Police, either in person or by telephone, and explain the circumstances why you wish to contest the ticket.
- **2.** If you wish to still contest the ticket after speaking with the Chief of Police, you must request that a formal "Parking Ticket Contest Form" be completed.
- **3.** A copy of this form and your parking ticket will be submitted, by our department, to the Coulee Region Joint Municipal Court, located at 415 Main St., Onalaska, WI 54650.
- **4.** A court date and time will be assigned by the staff member completing the form.
- **5.** You will be required to personally appear at the assigned court date and time and meet with the Village of West Salem's Attorney.
- **6.** If a satisfactory resolution is not achieved, you have the right to have a trial in front of the municipal judge in regards to the matter.
- 7. If you do not appear for your court date, or you are found guilty by the judge, your driver's license may be suspended if you fail to pay the required fine.
