# NOTICE OF PUBLIC HEARING

# Ordinance No. 530 Amending Chapter 8 Holding Tank and Septic Tank Waste Charges

The Village of West Salem Board of Trustees will conduct a public hearing pertaining to Ordinance No. 530 on Tuesday, May 21, 2024.

Ordinance No. 530, if adopted, will delete and re-create Sections of Chapter 8 of the Village Code of Ordinances in order to facilitate a fixed rate increase to licensed dischargers of low and medium strength holding tank waste and septic tank waste.

The changes proposed are as follows:

#### VI. Holding Tank Waste, Septic Tank Waste and Septage Waste Charges

#### 1. Low Strength Dischargers

Charges to licensed dischargers of low strength holding tank wastes shall be charged a \$15.00 per load fee plus charges computed on the following basis:

Assumed Strength

BOD5 SS Phosphorus User Charge Up to 500 mg/L Up to 1,300 mg/L Up to 6 mg/L

\$17.00 **\$21.00/1,000 gallons** (See Schedule 4C for calculations)

# 2. <u>Medium Strength Dischargers</u>

Charges to licensed dischargers of m e d i u m s t r e n g t h septic tank wastes shall be charged a \$15.00 per load fee plus charges computed on the following basis:

Assumed Strength

BOD5 SS Up to 1,600 mg/L

1,301 mg/L up to 5,000 mg/L

Phosphorus 6.1 mg/L to 12 mg/L User Charge \$30.00 \$34.00/1,000 gallons

Section III, Village of West Salem User Charge System Schedules, Schedule 4C Low Strength Waste Disposal Charges and Schedule 4D Medium Strength Waste Disposal Charges is hereby revised as follows:
