PURPOSE OF MEETING:

• Call Board of Review to Order and Roll Call

- Appointment of Chairperson
- Appointment of Vice Chairperson
- Verification that mandatory training requirement has been met
- Verification of Village Ordinance Section 1.24 Assessor responsibilities for the confidentiality of income and expenses information under Wis. Stat. Sec. 70.47(7)(af)
- Receive 2025 Assessment Roll and sworn statements from the Village Assessor
- Review 2025 Assessment Roll and perform statutory duties:
 - a. Examine the roll;
 - b. Correct description or calculation errors;
 - c. Add omitted property; and
 - d. Eliminate double assessed property.
- Discussion/Action Certify all corrections of errors under State law (Wis. Stat. Sec. 70.43)
- Discussion/Action Verify with the Assessor that open book changes are included in the 2025 Assessment Roll
- Allow taxpayers to examine assessment data
- During the first two hours, consideration of:
 - a. Waivers of the required 48-hour notice of intent to file an objection when there is a good cause;
 - b. Requests for waiver of the BOR hearing allowing the property owner an appeal directly to the circuit court;
 - c. Requests to testify by telephone or submit a sworn written statement;
 - d. Subpoena requests; and
 - e. Act on any other legally allowed or required BOR $\ensuremath{\mathsf{matters}}$
- Review Notices of Intent to File Objection
- Proceed to hear objections, if any and if proper notice/waivers given, unless scheduled for another date

- Consider/act on scheduling additional BOR date(s)
- Act on 2025 Assessment Roll
- Adjournment (or to a future date, if necessary)
