Prior to commencement of excavation work, permittee shall furnish the Director of Public Works or the Village Administrator an indemnity bond in the sum of Six Thousand (\$6,000.00) Dollars conditioned that the Contractor or the Permittee must furnish written evidence of public liability insurance of not less than \$1,000,000.00 for one person, \$3,000,000.00 for one accident, and property damage insurance of not less than \$1,000,000.00. This Permit is enforced by Village Ordinance No. 5.05 Street and Sidewalk Excavations.

PERMITTEE MUST CLEAN UP AND SWEEP UP ALL MUD, DIRT, SAND AND ANY OTHER MATERIALS FROM ALL STREETS AND SIDEWALKS AT THE END OF EACH WORK DAY PRIOR TO LEAVING THE JOB SITE.

Permittee will fill-up and place in good condition, all excavations and openings made in the street or any street right-of-way or sidewalk and will replace and restore the pavement over any openings it may make as near as can be to the state and condition in which it was found, and shall keep and maintain the same in such condition, normal wear ad tear excepted, to the satisfaction of the Village of West Salem for a period of five (5) years.

The applicant understands and agrees that the permitted work shall comply with all permit provisions and conditions listed on and attached to this form. Permit applications may be revoked or suspended for not complying with the provisions.
