Traffic Study Request for Proposals

President Schumacher reported that he recently met with Bob Gollnik of the La Crosse Area Planning Commission and was advised that La Crosse County has received a \$350,000 grant under the "Safe Routes for All" initiative. The grant will help fund traffic studies at various locations around the County. In West Salem, the intersections of where Crestwood and Waterloo meet County Road M is an area identified as one that would meet the requirements of the grant program.

There was no one present to speak for or against the request. A Special Permit to Own, Keep, or Harbor Chickens, submitted by Angela Hemker, was reviewed for recommendation to Village Board. There was no once present to speak for or against the request. Positive correspondence, however, was received from neighbors, who were in favor of the request. The Committee recommended approval of both requests to the Village Board.
